**ADMINISTRATIVE ITEM 1 – ADOPT A TENTATIVE MILLAGE RATE OF 2.15 TO LEVY AD VALOREM TAXES OF \$11,060, 607 FOR FISCAL YEAR 2011-2012.**

*Commissioner Philp made a motion to set the tentative millage rate at 2.15. Commissioner Partin seconded, brief discussion, all were in favor, motion carried. Commissioner Schweers read Resolution No. 2011-06 adopting the tentative millage rate.*

**ADMINISTRATIVE ITEM 2 – ADOPT A TENTATIVE BUDGET OF \$21,663,644 REQUIRING A LEVY OF AD VALOREM TAXES OF \$11,060,607 FOR FISCAL YEAR 2011-2012.**

*Commissioner Philp made a motion to adopt the tentative budget of \$21,663,644. Commissioner Messina seconded, all were in favor, motion carried. Commissioner Schweers read Resolution No. 2011-07 adopting the tentative budget.*

*Commissioner Partin made a motion to hold the Final Hearing on Thursday, September 22, 2011 at 5:01 p.m. at the Estero Fire Rescue Administrative Complex, 21500 Three Oaks Parkway, Estero, Florida 33928.
